- 1. Approve the Minutes of the August 27, 2024 Meeting
 - A. Tara made a motion seconded by Gaston to approve the minutes as presented. Motion passed unanimously.

 - A. The Equalization Tank project at the Plant has started and the pump has arrived.

 - 3. Steve has been in contact with Tyler from Mountain Air who will put together a price for doing both the Mechanical and Site work. If their price is reasonable, it would eliminate the need for a Clerk of the Works and Dave could let Ross Naramore know that the position is no longer available.
 - C. Steve repaired the last damaged manhole cover.
 - D. The Storm Water Permit renewal application is done and submitted and it is classified as "Administratively Complete"

5.Terri Medley

A. The Board authorized Terri to combine the two CDs that are coming due at Community National Bank and roll over the approximate total of \$544,000 into a Community National Bank 6 month CD with a rate of 4.5 and an annual yield of 4.6.

B. The Board authorized Terri to combine the two CDs that are coming due at the Federal Credit Union and roll the total of \$486,827 into a fixed 12 month CD at 4.1 with an annual yield of 4.5.
